Overview

“One of the most important tasks God has given us at this moment is to advance the cause of life.”
– *Supreme Knight Patrick Kelly*

Aid and Support After Pregnancy (ASAP), describes the Knights of Columbus’ efforts to support pregnant women, mothers and their new children by serving pregnancy resource centers and maternity homes. These pro-life, non-profits are lifelines to women and babies in need and offer essential services that make the difference between a baby being aborted and a baby being born in a supportive environment.

Pregnancy resource centers provide assistance to nearly 2 million clients each year. In 2021, Knights donated \$4.6 million and 469,000 volunteer hours to support these centers and the women and children they serve through cash donations and community service activities such as baby and maternity item drives. Through its Ultrasound

Initiative, the Order also donated \$5.6 million to centers for the purchase of 163 ultrasound machines in 2021 – bringing its total donations since 2009 to more than 1,550 machines valued at over \$75 million. These life-saving organizations would not be able to provide the level of assistance women and children need without support from our Order and collaborating parish communities.

Through the ASAP initiative, councils can now contribute even more support. For every \$500 a council donates to a qualifying pregnancy resource center or maternity home (up to \$2,000), the Supreme Council will donate \$100 more. Visit kofc.org/asap for resources.

This resource is designed to help councils learn how they can carry out the ASAP initiative and invite communities, especially their parishes, to join in these efforts. Resources including this handbook, posters and a brochure are available in Supplies Online under the Pregnancy Center Support program category in Faith in Action.

PRCs & Maternity Homes

Pregnancy resources centers, maternity homes, and the women and babies they serve, need our support more than ever. May our Founder, Blessed Michael McGivney, whose first confirmed miracle involved the healing of an unborn child, guide our efforts to love and serve life. Let's continue to show women and children in need that Knights are there with ASAP.

Identifying Pregnancy Resource Centers and Maternity Homes

Pregnancy resource centers and maternity homes, and the women and babies they serve, are in dire need of financial contributions, donations of material goods, and other volunteer services. Despite the essential services pregnancy resource centers provide to women and their new children, 90% of funding for pregnancy centers is raised locally and 80% of centers receive no government funding.

Every council should identify a pregnancy resource center or maternity home it can serve through the ASAP initiative. In order to qualify for financial support from Supreme, the organization must be in accordance with Catholic Social Teaching regarding life and the family: Qualifying organizations cannot provide or refer for abortion, abortifacients, or contraception."

The organization must also fall within the following categories."

1. Pregnancy Resource Centers

Non-profit pregnancy resource centers offer a variety of services to pregnant women, new moms and babies, such as counseling about the alternatives to abortion; abstinence education; referrals for legal, medical, housing, and social services resources; prenatal and parenting education; maternity/baby clothes, diapers; free ultrasounds and pregnancy tests, and other support.

2. Maternity Homes

Non-profit maternity homes offer short-term or transitional housing and support to pregnant women and new moms and their children, aged infant



to toddler (<5 years old). They can include live-in house parents, live-in staff, rotating staff, or shepherding/host homes.

Finding Organizations to Support

Pregnancy resource centers and maternity homes can be found by searching through databases available at heartbeartinternational.org, birthright.org and pregnancycarecanada.ca – among others. Local Catholic Charities, the Sisters of Life, diocesan pregnancy resource centers, and other organizations are also in need of support. Contact your state council's program team, your local parish pro-life coordinator or diocesan Respect Life Office or search online for these organizations. Many parishes are already involved with local pregnancy centers through the USCCB's Walking with Moms in Need initiative.

Action Steps

Serving Pregnancy Resource Centers and Maternity Homes

Through ASAP, for every \$500 a council or assembly donates to a qualifying non-profit pregnancy resource center or maternity home, Supreme will issue a \$100 grant to the same qualifying organization. The most a council or assembly can earn as an additional grant from Supreme for a pregnancy center or maternity home is \$400 per center or home supported, per year.

There are a variety of activities a council can organize to qualify for ASAP funds – most fall within the categories of financial support and material assistance:

- Financial Support includes: direct donations, Baby Bottle Drives, proceeds from fundraisers, open houses, etc.
- Material Assistance includes: donations of baby items (equipment, food, formula, diapers, wipes), clothes (maternity, baby, infant and toddler) and other items often listed on a center's or maternity home's website.



Please note that while volunteering and praying for a pregnancy center or raising funds for an ultrasound initiative are worthy causes, they do not fall within the guidelines of the ASAP program.

To qualify for additional \$100 donations, the council must complete the ASAP Grant Request Application, found at kofc.org/asap, and submit it to fraternalmission@kofc.org.

Suggested ASAP Activities

The following are tried and true examples of activities councils can carry out to support pregnancy centers and maternity homes. Before beginning an activity, consult your local center or home to see how you can collaborate.

BABY BOTTLE DRIVE

A baby bottle drive is a simple and effective way to engage your entire council and parish community in fundraising for local pregnancy centers and maternity homes. As the name suggests, the drive uses baby bottles to collect loose change, cash and checks from donors.

Action Steps

1. Ask your pastor for his permission to schedule a baby bottle drive. Drives can be conducted at any time of the year. Scheduling the drive around feast days or holidays, such as weekends from Mother's Day to Father's Day or Respect Life Month (October) can make the collections more successful.
2. Appoint a Knight to lead the drive. This Knight should take the lead on procuring the baby bottles, promoting the event, and organizing the collection of bottles. Bottles are sometimes provided by the pregnancy center. If not, ask council members to donate the bottles or arrange for their purchase. Bottles can be labeled with the Knights of Columbus emblem, your council name and number, the name of the beneficiary, and the

return date of the bottles. Also consider including a QR code or URL linking to an online donation portal. You can also include more information about your council and the beneficiary inside the bottle.

3. Distribute the baby bottles to parishioners after a Mass, council meeting or pro-life event. Encourage council members to raise as much funding as possible by sharing the initiative with friends and family. Consider promoting a fundraising goal.
4. Collect the bottles at the end of the campaign or at the end of each subsequent Mass, event or council meeting. Families and youth groups can be invited to participate. Record the number of bottles collected and amount of money donated. Bottles should be returned to your local pregnancy center, maternity home, or council.
5. Prepare for the donation of the funds collected through the drive. Be sure to arrange a photo shoot with the members of your council and the pregnancy center or maternity home's staff and volunteers. Make sure you wear Knights of Columbus branding. The photo shoot should be action oriented, not focused solely on the donation of the check. After the photo shoot, issue a press release.

BABY AND MATERNITY ITEM DRIVES

Pregnancy resource centers and maternity homes are in dire need of supplies. Councils can sponsor baby or maternity drives to collect essential items like diapers, wipes, and clothing. While babies are usually the main beneficiary of these events, the needs of pregnant women and new mothers should also be considered a top priority."

Action Steps

1. Ask your pastor for his permission to schedule the drive, which can be conducted at any time of the year. Scheduling the item drive around feast days or holidays, such as weekends from Mother's Day
2. Appoint a Knight to lead the drive. This Knight should take the lead on determining what items are accepted by the center, promoting the event, and organizing the collection of items.
3. Determine a location to collect the items. A crib or play pen, donated by a council member, can be used as an attractive centerpiece for collecting the items in a parish vestibule. Placing some items inside before the start of the drive will encourage more people to donate. Bags or totes can be handed out to participants to collect items. Baby bottles can also be provided so monetary donations can be made. A list of what items are needed should be advertised. One popular way to advertise items, particularly around the Christmas season, is to list items on tags on a Christmas tree.
4. At the end of the item drive, count the various items that were donated and estimate their value. This information can be used in press releases and thank you notes to participants.



to Father's Day or Respect Life Month (October) can make the drive more successful.

Action Steps

5. Prepare for the donation of the items collected through the drive. Be sure to arrange a photo shoot with the members of your council and the center or maternity home's staff and volunteers. Make sure you wear Knights of Columbus branding. The photo shoot should be action oriented, not focused solely on the donation of the check. After the photo shoot, issue a press release.

PREGNANCY CENTER OR MATERNITY HOME OPEN HOUSE

Pregnancy centers and maternity homes sometimes host "open houses" in which volunteers and their communities are invited to attend. These open houses raise awareness of the organization's services and offer an opportunity to meet the center's leadership and staff. Councils can help pregnancy centers and maternity homes host these important events and tie-in council fundraising activities before or during the event.

Action Steps

1. Contact the pregnancy center or maternity home to determine if it is possible to host an open house and if so, when.
2. Create a council committee and appoint a lead Knight to organize the council's support.
3. In advance of the open house, collect funds or items for the pregnancy center or maternity home for future donation at the event. Consider a baby bottle drive or item drive.
4. Identify the role your council can play in the open house. Councils, for example, can underwrite the event, arrange for a blessing of the location, and/or volunteer to support any events accompanying the open house such as entertainment, catering, and awards ceremonies. Any funds donated by the council to support the open house qualify for ASAP.
5. Promote the open house to your parish community and council.
6. Present a check or items to the center during or at the conclusion of the open house. A member of the council, such as the grand knight, should consider delivering brief remarks.
7. Arrange a photo shoot with the members of your council and the pregnancy center or maternity home's staff and volunteers at the event. Make sure you wear Knights of Columbus branding. The photo shoot should be action oriented, not focused solely on the donation of the check. After the photo shoot, issue a press release.

PROMOTING ACTIVITIES

Consider the following steps when promoting any ASAP activity:

1. Ask your pastor and parish administration to include K of C announcements in your local bulletin/parish newsletter.

Action Steps

2. Print and post posters in your church hall, parish school or other highly visible common area. Posters are available on Supplies Online.
3. Ask council officers and members to utilize these resources on their personal social media accounts and share with other parish groups leaders to help find pro-life supporters.
4. Ask your pastor to allow you to speak at select Masses – deliver a short (1-2 min) invitation to join your council's pro-life efforts. Staff or volunteers from the pregnancy center or maternity can also be asked to speak after Mass or a council meeting.
5. Personally invite people to attend after Mass and through email, phone calls and social media.
2. Fundraising activities should be used only to raise money for a worthy charitable organization, consistent with the Order's mission and our first principle of Charity. The beneficiary organization should be identified in advertising for the event.
3. Proceeds from a charity fundraiser cannot be used to pay for ordinary council expenses or liabilities. The proceeds must be disbursed as follows:
 - a. Payment of the expenses associated with the event;
 - b. Gift to the charitable organization.
4. If applicable, councils should obtain event insurance to cover all potential liabilities associated with the event.

AFTER YOUR ACTIVITY

Complete an ASAP Grant Application using the form provided at the end of this handbook or found at kofc.org/asap.

After the Financial Secretary or Faithful Comptroller receives the check in the mail from Supreme (which is made payable to the pregnancy center or maternity home), the council or assembly should arrange for its presentation to the center or home. Consider inviting the center or home's director, staff and/or clients to a council meeting or parish event to receive the check and thank all supporters. A sample letter template that can be used to accompany the check's delivery via mail is also available at the end of this handbook.

FUNDRAISING GUIDELINES

In planning and conducting charitable fundraising events, councils should be guided by the following principles:

1. Councils may use the name "Knights of Columbus" in conjunction with the fundraiser, so long as the individual council is identified within the name, i.e., "Knights of Columbus [Name of Council] Council No. 5748". Councils should not use the name "Knights of Columbus" as a stand-alone.



Building Support

Building Support for ASAP

Councils need not support life on their own. Pro-life advocates abound in parish communities and beyond. Here are some simple steps that can be taken to garner support for your ASAP activities.

1. Identify pro-life council members, parishioners and community members. Supporters can be found in places such as:
 - Existing Pro-Life Events (Marches and rallies for life, conferences and seminars)
 - Parish Groups (women's groups, pro-life, social justice, young adults)
 - Catholic Schools and Homeschooling Groups
 - Men's Catholic Conferences
 - Other Existing Pro-Life Groups
2. Discuss what your local pregnancy resource center or maternity home does for pregnant women, mothers and their new children. Use the talking points provided for conversation starters.
3. Explain your council's work, past and present, to support the pregnancy resource center or maternity home.
4. Invite prospective supporters to visit kofc.org/asap and to visit your next ASAP event. Send a follow-up "thank you" email after they attend.
5. Involve participants with other council events throughout the year, especially other pro-life events such as a march for life or rally, to keep them engaged.

TALKING POINTS TO INVITE SUPPORTERS

- Knights of Columbus believe in the dignity and worth of every human life, and we work tirelessly, through prayer and action, to support mothers and their children.
- In 2021, Knights of Columbus donated \$4.6 million and 469,000 volunteer hours to

pregnancy centers and maternity homes, providing maternity and baby clothes, diapers, food and other items to women in need. Join us in growing the pro-life safety net the Knights have long supported.

- Our Founder, Blessed Michael McGivney, devoted his life to the care of widows and orphans, and the Order's mission to support mothers in need and their children is a sacred responsibility we've carried for 140 years.
- In his historic encyclical "*Evangelium Vitae*" ... or the "Gospel of Life", Pope St. John Paul II addressed the value of human life, maintaining that societies and individuals, especially Christians, should do everything in their power to preserve this life.

GRANT REQUEST INSTRUCTIONS

Please review these guidelines before completing the application.

For every \$500 a council or assembly donates to a qualifying non-profit pregnancy resource center or maternity home (up to \$2,000), Supreme will issue a \$100 grant to the same qualifying organization. The most a council or assembly can earn as an additional grant from Supreme for a pregnancy center or maternity home is \$400 per center or home supported, per year. There is no cap on the number of pregnancy centers or maternity homes a council or assembly can support. Qualified donations can be through a monetary donation (e.g. cash, check etc.) or by donating items such as maternity or baby supplies purchased by the council or donated through collection drives. Money or items donated to each qualifying organization must be donated between July 1 and June 30 within the fraternal year applied for, and must amount to at least \$500.

Guidelines for Qualifying Organizations

The following organizations qualify to receive a grant:

- Non-profit (U.S. 501c3 or Canadian Registered Charities) pregnancy resource centers offering a variety of services to pregnant women, new moms and babies, such as counseling about the alternatives to abortion; abstinence education; referrals for legal, medical, housing, and social services resources; prenatal and parenting education; maternity/baby clothes, diapers and other support.
- Non-profit (U.S. 501c3 or Canadian Registered Charities) maternity homes providing housing services or post-birth transitional housing to pregnant women, new mothers and their children aged infant up to toddler (<5 years old).

The following do not qualify to receive a grant:

- Organizations not mentioned in the categories of qualifying organizations listed above.
- For-profit organizations.
- Organizations outside of the United States or Canada.
- Individuals or families.
- Donations made for the purchase of ultrasound machines do not qualify for a grant through ASAP.
- Organizations that provide or refer for abortion, abortifacients, contraception or other associated practices inconsistent with Catholic moral and ethical principles.
- Organizations that have a mission statement which is inconsistent with the teachings of the Catholic Church, or are not welcoming of Catholics.

Please note: Pregnancy resource centers and maternity homes who are affiliated with Heartbeat International, Catholic Charities or dioceses, or are past participants of K of C Ultrasound Initiatives automatically meet the criteria for participation per the two bullet points above. Identify affiliates by searching the database available at heartbeatinternational.org or through the Ultrasound Initiative map available at kofc.org/asap. If a center or home is not an affiliate, a member of the council or assembly should contact the center or home's director to confirm it meets the requirements above. When in doubt, consult with your parish pastor or local diocesan Respect Life Office.
